THIS IS NOT THE MONTHLY PAYMENTS; THIS IS IN ADDITION TO THE BALANCE WE MUST MAINTAIN SEPARTELY. THE PRINCIPAL BALANCE OWED USDA AS OF 12-31-24 WAS A COMBINED TOTAL OF \$483228.32 SCHEDULED TO BE PAID OFF IN THE YEAR 2044.
